- While churches and religious bodies cannot be compelled to host same-sex "marriage" ceremonies in their facilities or on their grounds, every church needs to have an explicit statement within its Statement of Faith/Doctrine, Constitution and Bylaws and any property-use documents to the effect that the only biblically approved act of sexual intimacy exists between a man and a woman within the covenant of marriage, and that advocates or practitioners of other points of view, while welcome to attend, may not be members or allowed to marry on church grounds.
- Opposition to same-sex "marriage" is not hatred or bigotry. It is grounded
 in the teachings of Scripture, which are "settled in heaven forever" (Ps.
