

Marriage Is God's Plan

God has ordained three basic institutions: the church, the government, and the family. The family is the first and foundational institution of human society, composed of individuals related to one another by marriage, blood, or adoption.

According to the Bible, marriage can only be the union of one man and one woman (Gen. 1:27; 2:24). It is the only proper place for sexual relations and is intended to be a life-long relationship. While some in the culture might seek to redefine what constitutes a family, God's perspective is unchanged.

Every civilization in history is built upon the institution of marriage. The welfare of children, the propagation of the faith, the wellbeing of society, and the orderliness of civilization are all dependent upon the stability of marriage according to the divine pattern.

Marriage According to Jesus

Jesus was clear about the definition of marriage: "Haven't you read," he replied, "that at the beginning the Creator 'made them male and female,' and said, 'For this reason a man will leave his father and mother and be united to his wife, and the two will become one flesh'? So they are no longer two, but one. Therefore what God has joined together, let man not separate."(Matthew 19:4-6). Jesus affirmed God's plan for marriage, thus rejecting all other sexual relationships – including homosexual relationships.

Marriage Is Under Fire

Unfortunately, many in our culture are seeking to redefine marriage, and therefore destroy it altogether. Homosexual activists and their allies refuse to stop short of legalizing same-sex "marriage." When the God-given pattern for marriage is undermined, the whole foundation of society becomes unstable. Alarmed by this growing threat to traditional marriage, a number of states have taken action.

Marriage Is Being Defended

While marriage has been redefined to include same-sex "marriage" in a few states (the latest was New York), 30 states have voted for constitutional amendments preserving natural marriage (A 31st state, Hawaii, allows the legislature to decide). Many other states have a Defense of Marriage Act (DOMA) to define marriage between one man and one woman, but these laws could be overturned by courts or altered by legislators. Plus, the federal DOMA has been left undefended by President Obama's Justice Department and is under attack in the courts. Natural marriage must be defended.

Marriage in Minnesota

Some might say, "There doesn't seem to be an immediate threat to natural marriage in Minnesota." Yet same-sex "marriage" in this state could be closer than you think. An amendment to the State Constitution is the only defense against the relentless quest to redefine marriage. Thankfully, your state legislature passed a bill that allows Minnesotans to vote for a constitutional amendment that protects the Biblical definition of marriage. The ballot measure simply states:

Shall the Minnesota constitution be amended to provide that only a union of one man and one woman shall be valid or recognized as a marriage in Minnesota?

We are on the verge of finally protecting marriage for our children and grandchildren in the Minnesota Constitution. So please make the investment to vote "yes" on this question. Let's finish strong. Let's stand for marriage!

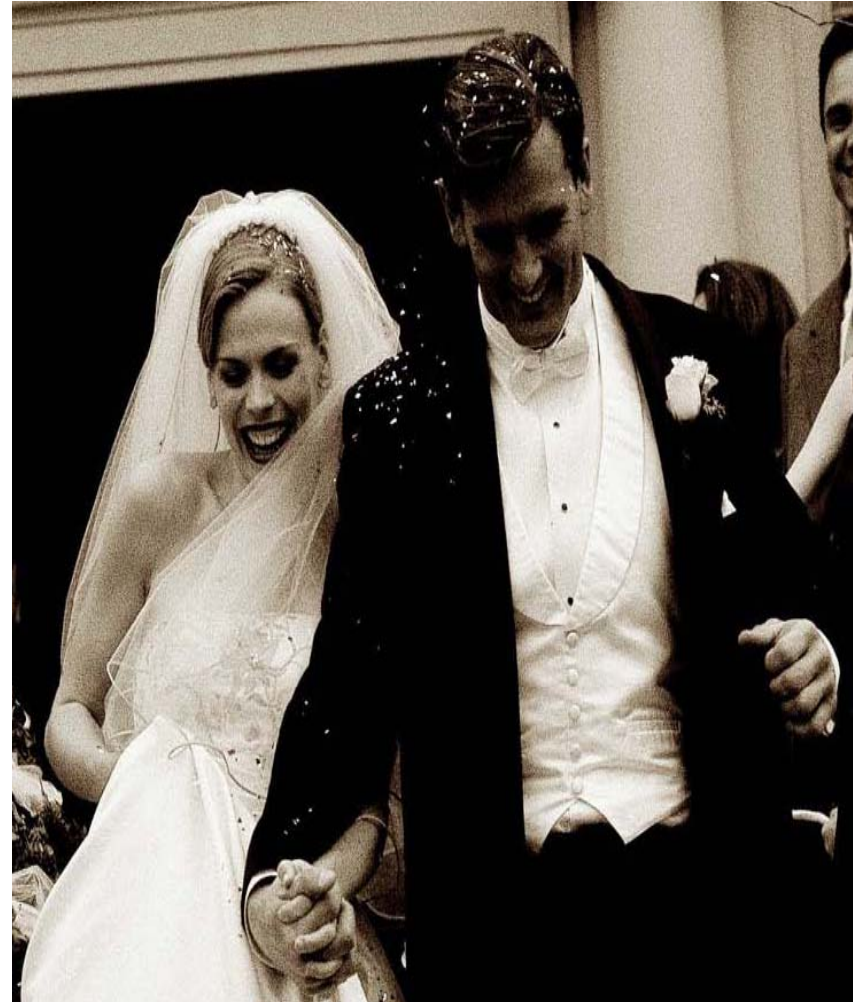
Action Step 2: PRACTICE: We need to *practice* biblical principles for healthy marriage as a positive witness (See Ephesians 5:22-33).
