

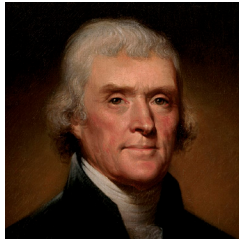

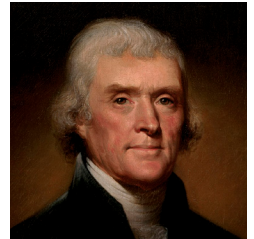

### 1. PRAY FOR RELIGIOUS FREEDOM TO BE VALUED IN PUBLIC LIFE

Scripture commands that we are to pray for those in authority (1 Tim. 2:1-4). Ask God to help leaders see that religious freedom is an unalienable right, a right that does not have to be forfeited when believers conduct business, engage in public speech, serve in office, or teach in public schools. Ask God to soften the hearts of judges, elected officials, and public servants to the plight of those who are being harassed because of their deeply held beliefs and strengthen their resolve to defend the religious freedom of all Americans.

“Be it enacted by the General Assembly, That no man shall be compelled to frequent or support any religious worship, place, or ministry whatsoever, nor shall be enforced, restrained, molested, or burthened in his body or goods, nor shall otherwise suffer on account of his religious opinions or belief; but that all men shall be free to profess, and by argument to maintain, their opinion in matters of religion, and that the same shall in no wise diminish enlarge, or affect their civil capacities.”

### 3. PROMPT CONGRESS AND THE PRESIDENT TO PROTECT RELIGIOUS FREEDOM IN POLICY AND LAW:

Rep. Steve Scalise (R-La.) and Sen. James Lankford (R-Okla.) have introduced the Free Speech Fairness Act which proposes to amend the Johnson Amendment to allow non-profits (i.e., pastors and churches) to engage in political speech and activities. This provision was added to the House tax reform package and needs to be maintained in a final House and Senate bill, and the sunset of 2024 needs to be removed. Rep. Mike Kelly (R-Pa.) and Sen. Mike Enzi (R-Wyo.) sponsored the Child Welfare Provider Protection Act, which prevents faith-based adoption and foster-care agencies from being forced to affirm views of marriage that go against their beliefs. Congress must also pass the Federal Disaster Assistance Nonprofit Fairness Act of 2017 sponsored by Rep. Chris Smith (R-N.J.) and Sen. Roy Blunt (R-Mo.) to ensure that FEMA does not discriminate against churches when providing loans to rebuild in the wake of major disasters.
