“My substance was not hid from thee, when I was made in secret, and curiously wrought in the lowest parts of the earth. Thine eyes did see my substance, yet being imperfect...”

Life made in the image of God is a fundamental human right that begins at conception. According to our Declaration of Independence, “all men... are endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness.” The order is significant. Life is the first God-given right of every human being. If you do not have life, you certainly cannot enjoy liberty or pursue happiness.

Unfortunately, our God-given right to life in America has been undermined in our “culture of death.” Hundreds of thousands of innocent unborn babies are put to death every year through surgical abortion. Fully 1 in 5 pregnancies end in abortion. In addition, 1 in 3 women were churchgoers at the time of their abortion, so there are many wounded women in the pews. Yet the overwhelming majority of those preborn children are simply sacrificed on the altar of convenience. Nearly 60 million preborn children have been killed by abortion since the Supreme Court ruling on January 22, 1973.

Recent polling shows a plurality of Americans (47 percent) view abortion as morally wrong, while a minority (43 percent) view it as morally acceptable.

- **78 percent** endorse significant restrictions on abortion and would limit it to, at most, the first three months of pregnancy.
- By a **25-point margin** (55 to 30 percent), Americans say that abortion ultimately does a woman more harm than good.
- **62 percent** of Americans oppose taxpayer funding for abortion
- **41 percent** would restrict abortion only to cases of rape or incest, or to save the life of the mother.
- **12 percent** of the general public believe that abortion should be illegal in all circumstances.

3. Contact your Representative and Senators by calling the U.S. Capitol switchboard at (202) 224-3121, or visit frc.org and click on “More” tab, then “Contact Officials.” Urge them to support pro-life legislation:

- Defending the Hyde Amendment in annual House appropriations bills, which for the past 30 years has prevented taxpayer funding of elective abortions.
- The No Taxpayer Funding for Abortion Act in the Senate, which permanently codifies the Hyde Amendment and other pro-life provisions across government programs by preventing federal funds from paying for abortion and healthcare plans that include abortion.

4. Educate yourself on pro-life arguments. Read the best arguments from science, the law, and women’s rights to advance the pro-life case against abortion to your friends, family, and neighbors.
